PRICES: All prices are \$USD F.O.B. our warehouse. Taxes extra. Prices are subject to change without notice. All shipments will be invoiced at prices in effect on date order is placed. All orders accepted subject to credit terms and limits. **Past due invoices subject to service charge of 1-1/2% per month.**

FOB POINTS: 108 Business Center Drive, Corona, CA 92880

INVOICE TERMS: 1%, 10 days following date of invoice. Net 30. Minimum net charge per invoice is \$25.00 — all taxes extra. **Credit card payments do not qualify for early pay discount.**

FREIGHT TERMS: F.O.B. Collect. Otherwise, see price list for qualifying for prepaid options.

PRODUCT WARRANTY: Products manufactured by Nuvia Water Technologies, Inc. hereinafter referred to as NWTI are warranted to do the work for which they are intended where properly installed and operated. NWTI warrants each new domestic product manufactured and sold by them to be free from defects in materials and workmanship. The length of the product warranties varies. Consult the product Owner's Manual for specific warranty information.

COMPONENT WARRANTY

Components manufactured by NWTI not sold as a part of a system or part of an assembled product are warranted to do the work for which they are intended where properly installed and operated. Fiberglass tanks 5 years under normal use; Control valves and electronics - 5 years under normal use; Brine tanks and assemblies - 5 years under normal use; All other components - 1 year under normal use; Any other components not manufactured by NWTI are limited to the warranty given by the manufacturer of the component. All other products supplied by NWTI are subject to the warranties of their respective manufacturers.

CONSEQUENTIAL DAMAGES

NWTI shall in no event be liable for consequential damages or contingent liabilities arising out of the failure of any product, its power units or its accessories. No express, implied or statutory warranty other than herein set forth is made or authorized to be made by the manufacturer.

RETURN OF GOODS: Authorization number must be obtained before returning any merchandise. **NOTE: All RETURN OF GOODS:** Permission and an authorization number must be obtained before returning any merchandise. **NOTE:** All material returned to NWTI must be returned freight prepaid.

New material returned for credit covered by warranty will be credited at the discretion of NWTI less a minimum 20% restocking fee.

Goods returned under warranty, found defective will be repaired, replaced, or credited under warranty, no charge to the customer, return freight prepaid. Warranty does not obligate NWTI to bear the cost of field labor or mileage. Goods returned out of warranty for repair and returned to the customer these will be repaired and returned and subject to the normal charges for this work. Special parts or custom-built items cannot be returned for credit.

CLAIMS: All goods shall be deemed delivered to purchaser at the time they are placed in the hands of carrier and consigned to purchaser. Loss, damage or destruction of any said merchandise is assumed by purchaser. No claims may be made for shortages unless made within 10 days from receipt of merchandise.

TITLE: Title and ownership of goods will remain with NWTI, and will not pass to the customer until all debts owing to NWTI have been paid in full.

FORCE MNEURE: The company shall not be held responsible or in default under any contract or order or liable to anyone for any losses or damages arising from delay, inability or failure to fill orders or to perform its obligations caused by acts of God, force majeure, fire, flood, explosion, accident, strike or other labor trouble, the exercise of civil or military authority, scarcity of labor or materials, transportation difficulties, demand exceeding supply, voluntary or compulsory application of priority rationing, limitation of production or any regulations by governmental order or any cause or circumstances beyond its reasonable control or resulting from any scheme of allocation among its customers in the event of shortage or delay.
